INTRODUCTION

This document is the Review of Protected Open Spaces prepared by Knight Kavanagh & Page (KKP) for Canterbury City Council (CCC).

The Canterbury District Local Plan (adopted 2017) currently recognises 192 Protected Open Spaces (POS). These are specifically protected under Local Plan policy OS9. As part of an internal audit, several key tasks were identified including the need to further review the POS in context of an Open Space Assessment and Strategy (also being undertaken by KKP on behalf of CCC).

Consequently, the following tables are a summary to the review of the 192 POS

- Ensuring POS sites entirely covered by an OSS PPG17 typology are included within the Open Spaces Strategy (OSS). Other sites can *only* be included in the OSS typologies *if* they are publicly accessible *and* a recognisable typology. Some sites may not meet these criteria, but could have a landscape or visual amenity value, and these are identified.
- Assess POS sites partially covered by an OSS typology, and recommend whether the OSS record should be extended to match the POS record, whether the POS should have a different OSS classification, whether a different designation/ protection is needed or make an alternative recommendation.
- Assess whether the remaining sites should be included within the OSS and associated mapping. Provide recommendations from the outcome of the assessments (for example many sites appear to be education or sports facilities which should already be covered in the PPS).
