Notice is hereby given that KENT COUNTY COUNCIL intends to make the above Order under sections I(1), 2(1) to (3), 3(2), 4(1) and 4(2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, (the Act), and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act.

The effect of the Order is to amend the Kent County Council (Canterbury) (Traffic Regulation and Street Parking Places) (Consolidation) Order 2018 by introducing new or varying existing parking and waiting restrictions on the following lengths of road in Canterbury:

Name of street	Side of street	Specific length
Cockering Road	North Western	Between points 18 metres North East and 32 metres South West of the junction with St Nicholas Road
Cockering Road	North Western	Between points 75 metres North East and 22 metres South West of the junction with Strangers Lane.
Cockering Road	South Eastern	Between points 29 metres South West and 22 metres North East of the junction with Road 2.
Cockering Road	South Eastern	Between points 67 metres South West and 39 metres North East of Road 3.
Strangers Lane	Western	From the junction with Cockering Road for a distance of 43 metres in a Northerly direction.
Strangers Lane	Eastern	From the junction with Cockering Road for a distance of 24 metres in a Northerly direction.
St Nicholas Road	Western	From the junction with Cockering Road to a point I metre South of the common boundary of Nos 21 and 22 St Nicholas Road.
St Nicholas Road	Eastern	From the junction with Cockering Road for a distance of 37 metres in a Northerly direction.
Thanington Road	Southern	From the junction with St Nicholas Road for a distance of 65 metres in a Westerly direction.
Road 2	Both	From the junction with Cockering Road for a distance of 17 metres.
Road 3	Both	From the junction with Cockering Road for a distance of 19 metres.

Further changes not detailed or required within the Traffic Regulation Order but subject to consultation are as below:

St Nicholas Road

Placement of a new Bus Stop clearway outside numbers 2 and 3 St Nicholas Road.

Strangers Lane

Removal of Disabled drivers' parking bay outside number 2 Strangers Lane

Thanington Road

Placement of a new Bus Stop clearway 65 metres West of the junction with St Nicholas Road for a distance of 19 metres in a Westerly direction.
