Proposed variation to the Premises licence:

- To be able to serve a limited selection of alcohol from the Tower House Tea Hut, located on the terrace area during the period March to October weather permitting. When inclement weather the tea hut will be closed.
 - Operational hours between 10am to 8pm depending on weather conditions and closure times of the park.
 - Would like to offer a limited range of beers, wines, sparkling wines and spirits with mixers in cans. All alcoholic drinks to be poured into biodegradable/recyclable or polycarbonate drinking vessels. No glass will be given to customers.
- To be able to play low volume recorded music outside on the terrace during a wedding reception, function, civic or community event – easy listening genre.

Many hirers ask to be able to play music on the terrace during their wedding or social gathering to enhance the atmosphere. This music would be at a low background volume level. By no means is this for dancing or disco!

Staff have a Decibel monitor mobile phone application and will monitor the sound throughout an event, to not cause public nuisance. Staff at the venue will be in control of the music.
