**CA/25/01812: 15 High Street, Canterbury, Kent, CT1 2JE** Application for Listed Building Consent for external and internal alterations including installation of external signage to front elevation, repair and re-paint front elevation, removal of internal stud walls, installation of new flooring, installation of new lowered ceiling, installation of new accessible toilet, repair and enhancement of existing fire chimneys which include exposing brickwork, install new internal lighting, install new air conditioning and installation of working bar area. **Applicant: Director Matthew Ebner**  
Reason: Affects the setting of a listed building in a conservation area.
