1. Introduction

- 1.1. This statement sets out how Canterbury City Council (the council) have worked to comply with the Duty to Cooperate (DtC). The statement demonstrates a history of collaboration and engagement with neighbouring authorities, public bodies and stakeholders in the preparation of the 2040 Local Plan.
- 1.2. The statement sets out how cooperation has maximised the effective shaping of the strategies and policies within the Local Plan, and demonstrates a positive and continuous partnership working on strategic issues that transverse local authority boundaries. It is worth noting that this statement represents the first stage of the Duty to Cooperate, and the process is ongoing. An updated statement will be issued at the Local Plan examination stage.
- 1.3. The statement is structured by key policy areas where there has been cooperation and engagement with relevant parties, and highlights the practical policy outcomes that have so far resulted from cooperation.
- 1.4. The statement also reports how the DtC is being met on an ongoing basis and is continuing through plan implementation and monitored through the Annual Monitoring Report.
- 1.5. The statement incorporates the Statements of Common Ground (Appendix A) and the list of Duty to Cooperate meetings (Appendix B), as evidence that the DtC has been satisfied.

2. Legal and national policy requirements

- 2.1. The DtC stems from the Localism Act 2011, and is highlighted in paragraph 24 of the National Planning Policy Framework (NPPF) and in the National Planning Practice Guidance (NPPG). The Act places a legal duty on local planning authorities (LPAs) and other prescribed bodies to cooperate with each other on strategic cross boundary matters, including throughout the preparation of local plans. Cooperation is an ongoing process, including through implementation.
- 2.2. The Local Planning Authorities (LPAs) that the council shares boundaries with are listed below, along with their stages of Local Plan process.

- 2.3. Prescribed bodies
- 2.4. The council engages with prescribed bodies on relevant strategic issues, varying in frequency and approach dependent on the nature and scale of the issues. Many of these bodies are considered to play a key role in the development of the Local Plan, and therefore cooperation between them and the council is vital to make the Local Plan as effective as possible on strategic cross boundary matters.

- 2.5. The DtC requires on-going constructive and active engagement on the preparation of local plans and other documents, in particular in connection with strategic cross boundary matters.
- 2.6. For the purposes of the DtC, a strategic cross boundary matter is defined as relating to the sustainable development and use of land or infrastructure that has or would have a significant impact on at least two local planning authority areas.
- 2.7. The council has engaged with its neighbouring local authorities to discuss and agree what the relevant cross boundary strategic matters are, and these are summarised in Section 3. These issues vary between each local authority but generally include topics such as housing, the local economy, infrastructure and the environment.

3. Structures for cooperation

Approach to cooperation

Regional - Kent wide

- 3.1. Regional cooperation is important to understand issues affecting the wider south east, and the council continues to be involved with, and contribute positively to regional planning such as through the Transport for the South East Transport Strategy, the Network Rail Connectivity Strategy and the National Highways Scheme for the Lower Thames Crossing.
- 3.2. At the Kent level, the council has established structures in place such as the Kent Chief Planners Group and Kent Planning Policy Forum (KPPF), where county-wide issues are discussed and information can be shared. These groups also act as the key point of contact with the Greater London Authority, and the London Plan is a standing item at KPPF. The Kent Nature Partnership (KNP) focuses on protecting the natural environment in Kent and the council works with KNP to formulate environmental strategies and to meet Kent wide environmental targets. Regular meetings with the Kent leaders and Chief Executives are also held to discuss and share information on county-wide issues.
- 3.3. There has been ongoing collaboration with KCC throughout the Local Plan preparation process, identifying large scale issues in particular the issues that KCC has responsibility for. This has notably involved transport, education planning and minerals and waste management.

Sub-regional and topic based

- 3.4. The council is a member of the East Kent Regeneration Board along with KCC and east Kent LPAs. The Board is a key decision-making body for infrastructure and regeneration schemes, and has developed a set of shared objectives for growth in East Kent, formally through the East Kent Growth Framework in 2017.
- 3.5. As part of the East Kent DtC group, issues concerning East Kent are discussed and information is shared. The East Kent LPAs have formalised this arrangement through a Memorandum of Understanding which formalises the need for cooperation and engagement on strategic infrastructure planning matters.
- 3.6. Topic based groups follow on from key strategic issues, and discussions are centred around key matters. The council has established groups over the relevant geographies to progress

specific issues. For example, the Nutrient Neutrality Working Group is made up of Stodmarsh catchment LPAs and KCC and meets regularly to engage on the nutrient neutrality issue affecting Stodmarsh Special Area of Conservation. The Kent Downs AONB Unit, which the council is a member of along with Ashford Borough Council, Folkestone and Hythe District council and Dover District Council, provides for an appropriately joined-up approach to management of the Kent Downs AONB, which included the production of the AONB Management Plan (2021-2026). The North Kent and East Kent Strategic Access Management and Monitoring Strategies (SAMMS) groups were established to focus on the joint management of important habitats, namely the North Kent marshes and Thanet Coast and Sandwich Bay. Topic based meetings with Kent LPAs, KCC and National Highways enable constructive discussion on strategic issues such as the M2/A2, including updates on transport modelling and topic-specific discussions.

Local scale collaboration

- 3.7. A critical part of the DTC involves the collaboration with the other local authorities in East Kent – Ashford Borough Council, Dover District Council, Thanet District Council and Folkestone and Hythe District Council as well as Swale Borough Council. Informal meetings between individual districts to discuss key strategic cross-boundary issues were key in the formation of Statements of Common Ground.

Statements of Common Ground

- 3.8. Paragraph 27 of the revised National Planning Policy Framework (2019) sets out the requirement for the preparation of Statements of Common Ground (SOCGs) as part of the process of preparing a Local Plan.
- 3.9. As part of the preparation of the new Local Plan, the Council has prepared SOCGs with neighbouring local planning authorities to demonstrate the undertaking of effective and on-going cooperation.
- 3.10. The purpose of the SOCGs is to:
- (1) Define which strategic matters require cooperation;
 - (2) Set out which strategic matters we have an agreed position on; and
 - (3) Set out where further work is required, and the progress to date in addressing these matters.

3.11. The following sets out progress and status of the Council's Statements of Common Ground with neighbouring authorities. The council will continue to monitor the statements, looking out for any changes and ensuring that they are kept up to date.

The council has endeavoured to get the SOCG with Thanet District Council agreed, and will continue to cooperate with them in an effort to come to a joint agreement.

4. Summary of engagement and outcomes of cooperation on strategic issues

This section outlines the strategic issues which require cross-boundary cooperation, split into the topics of housing, economy, infrastructure and environment. The tables below outline the bodies involved in cooperation and a brief description of each strategic issue as well as the current status of the issue and the next steps. This summarises the current situation that agreement has already been reached on the majority of cross boundary strategic matters, while ongoing cooperation is needed to address those matters which remain currently unresolved.

Housing

- 4.1. Housing need and distribution is a key area of plan making where cross boundary cooperation can be required. Housing Market Areas (HMAs) do not always follow administrative boundaries and it is important to consider issues of housing need and supply at a wider spatial scale. Following the NPPF, the council worked together with neighbouring LPAs at HMA level to plan strategically for housing provision and has reached agreement that each LPA plans to meet its own housing needs within its own administrative boundary. Through this process it is also recognised that Gypsy and Traveller accommodation is not considered to be a key issue in terms of cross boundary impacts.

Economy

- 4.2. As economic market areas often overlap LPA boundaries, it is important to consider issues of employment need and supply at a wider spatial scale. The council has cooperated with LPAs to plan strategically for employment provision and has reached agreement that each LPA plans to meet its own employment needs within its own administrative boundary. .

Infrastructure

- 4.3. The council has cooperated constructively with key infrastructure providers throughout the development of the Local Plan to assess the impacts of planned growth on the delivery of their services, and to identify effective solutions to mitigate impacts or create additional infrastructure capacity. Where the identified need for infrastructure raises cross-boundary issues, the council has worked constructively with neighbouring authorities to address these.

As part of the SOCGs, local authorities have agreed that parts of this corridor are already at capacity and require upgrades to support growth and economic development.</p> <p>CCC is continuing to engage and share information on transport modelling to determine respective impacts and mitigation solutions where necessary, and progress is outlined in the SOCGs with ABC and TDC.</p>

Environment

- 4.4. The council has cooperated constructively with key statutory bodies throughout the preparation of the Local Plan to assess the impacts of planned growth on the natural and historic environment, and identify effective solutions to mitigate any impacts. Involvement with groups such as the Nutrient Neutrality working group and Birdwise ensure effective engagement on these cross-boundary issues.

5. Conclusions

- 5.1. This statement demonstrates that the council continues to take a proactive and structured approach to compliance with the DtC throughout the preparation of the draft Local Plan. The Council has undertaken structured discussions and ongoing engagement with neighbouring authorities, infrastructure providers and key stakeholders, and has demonstrated collaborative working on the strategic priorities set out in the NPPF, resulting in tangible outcomes and agreements.
- 5.2. This statement represents the first stage of the Duty to Cooperate. Cooperation is an ongoing process which the council will continue to monitor regularly. An updated Duty to Cooperate statement will be issued at the Local Plan examination stage.
- 5.3. The cross-boundary strategic matters have been agreed between LPAs and on the vast majority of these we have reached an agreed position. There are currently three matters which remain ongoing and we are continuing to cooperate with the relevant bodies to find solutions that work for all stakeholders, including the possibility of preparing separate SOGCs:
- The nutrient neutrality issue at Stodmarsh is being discussed fortnightly by the Nutrient Neutrality working group and key stakeholders as we work towards a Catchment-wide Mitigation Strategy. The council will look to prepare a SOCG with relevant parties regarding this issue.
 - Transport issues, particularly surrounding the M2/A2, remain ongoing with collaboration between LPAs, KCC and Highways England. The council will look to prepare a SOCG with relevant parties regarding this issue.
 - Cross-boundary impacts on the Dover area resulting from the draft allocations at Cooting Farm (Policy R1), South Aylesham (Policy R20) and Canterbury Business Park (C21) will also require further consideration. A revised SOCG has been sent to DDC to reflect this.
- 5.4. The Council recognises that the DtC is an ongoing requirement and will continue to monitor and engage with neighbouring LPAs, key infrastructure providers and stakeholders through the development and delivery of the draft Local Plan to keep all issues under review.

1. Overview

- 1.1 This Statement of Common Ground (SOCG) reflects the agreed position between the parties.
- 1.2 The purpose of this SOCG is to set out the areas of agreement on key strategic matters and the basis on which the parties will continue to work together to meet the requirements of the Duty to Cooperate.
- 1.3 The geographical relationship between the parties, reflecting local authority boundaries, is represented at Figure 1.

2.0 Key strategic matters

2.1 The NPPF defines the topics considered to be strategic matters. The strategic matters relevant to CCC and DDC are:

- **Housing** - housing market area, meeting housing needs;
- **Economy** - economic market area; town centres;
- **Infrastructure** - transport, education; and
- **Environment** - habitats regulations issues, landscape.




